INTRODUCTION

ASK Training & Learning (ASK T&L hereafter) is a development consulting organization that provides consulting and strategic advisory services in form of needs assessments, formative and summative researches, monitoring and evaluation of development projects and programs, Capacity building and long term accompaniment in organization development and project cycle management to strengthen programs.

Evaluation is one of the core competencies of ASK T&L. We have been conducting independent assessments of various aspects of development projects and programs to enhance learning and support positive, sustainable changes. We have successfully completed more than 350 evaluations and assessments, covering over 534 organizations across nine countries (Afghanistan, Bangladesh, Cambodia, India, Indonesia, Myanmar, Micronesia, Nepal, and Sri Lanka), supported by 122 funding agencies and corporate foundations.

Over the years, high-quality, professional evaluations have become increasingly important in the development sector. Both donor agencies and project-implementing organizations now recognize their value in assessing program effectiveness, improving accountability, and informing decision-making.

Encouraging Open Dialogue with Objective Analysis

- **Stakeholder Ownership:** Emphasis is placed on fostering ownership among stakeholders for the findings and recommendations, encouraging accountability and engagement in follow-up actions.

Recognizing Organizational Efforts Through Evaluation

Use-Focused Evaluations

We conduct evaluations that help organizations reflect on, analyze, and improve their interventions, boosting efficiency, accountability, and knowledge in the development sector. Our evaluations focus on enhancing the relevance, effectiveness, efficiency, and sustainability of programs, ultimately improving implementation quality.

We use a "realistic" approach, analyzing outcomes, context, and mechanisms to understand what worked, for whom, and in what circumstances



Impact Assessment

Impact assessments play a crucial role in our evaluation process by examining the long-term effects of development programs on target communities. These assessments not only highlight the outcomes but also identify the underlying factors that contributed to the success or limitations of the impacts.

By analyzing these factors, we help development sector actors learn valuable lessons, enabling them to replicate best practices or adjust strategies for greater effectiveness in future initiatives.



Organizational Assessment

We conduct comprehensive assessments of all aspects of an organization to support informed decisions for future growth and development.

The assessment involves a thorough analysis of the organization's governance, management systems, programs, policies, and overall capacity, offering recommendations to improve strategies and enhance organizational effectiveness and synergy.

Outcome Harvesting Assessment

We undertake outcome harvesting to understand, map, and document the various outcomes achieved through the implementation of projects and programs on the lives of target beneficiaries.

This process focuses on objectively collecting evidence of all the changes that occur during or at the end of a program in the communities and the lives of the people. We analyze the contribution of a particular program in achieving these outcomes and map other factors or contributors involved in the process of change.

Feasibility Assessment

We conduct feasibility assessments for NGOs at the request of donor organizations or corporates to evaluate their suitability for implementing programs, projects, and CSR initiatives. A comprehensive assessment is carried out to identify the current status, capacity, and future needs of a program, evaluating its feasibility and applicability before implementation.

This involves a thorough analysis of contextual realities, needs, strengths, concerns, opportunities, challenges, and the appropriateness of proposed plans, budgets, human resources, and sustainability strategies to recommend an appropriate implementation plan.

Monitoring

We conduct periodic assessments of the level of implementation of defined activities and the attainment of corresponding outputs/results for ongoing projects or programs.

We critically examine the processes of implementation—activities and accomplishments—to generate a detailed assessment of the progress made. Monitoring results are effective in ensuring that projects remain on track and help highlight internal issues and external challenges that may affect project performance, enabling the development and timely implementation of remedial measures.
